Memorandum of Understanding between the

National Institute of Mental Health Rehabilitation, Sehore is a National Institute, presently having office at NH-46 Bhopal Indore Highway, Sherpur, Sehore, Madhya Pradesh 466 001 (Hereinafter referred to as "NIMHR", or "First Party") which expression shall, unless it be repugnant or contrary to the subject or context thereof, be deemed to mean and include its assignees, nominees, and legal representatives, acting through its (Signatory) Dr. Narendra Kumar, Deputy Registrar (Offg.) of the FIRST party;

AND

Vasundhara Welfare Foundation, having its registered office at Brahmapuri colony Bilkisganj, District Sehore, Madhya Pradesh 466 001, was established on 04.11.2015 at Sehore. The Institution is conducting important works like formation of self-help groups, training, women empowerment, farmer welfare, de-addiction campaign through education, health, environmental protection, culture, livelihood mission at Sehore, MP, India which term shall unless repugnant to the context thereof, be deemed to mean and include its successors-in-interest and permitted assigns, represented by its authorized signatory, Director of the SECOND Party.

Vasundhara Welfare Foundation and **NIMHR** are hereinafter individually referred to as "Party" and collectively as "Parties/ Partners", as the context may require.

This Memorandum of Understanding (MoU) is made on 03.07.2025 by the signatories of both the above Parties.

1. Directory

1.1 Vasundhara Welfare Foundation will enlist NIMHR Sehore in its National Directory with details about the services being provided by the institution to ensure ease of access for caregivers from Madhya Pradesh.

2. Workshops/ Vocational desk

2.1 Vasundhara Welfare Foundation will set up helpdesks once every two months for two days to guide parents regarding Madhya Pradesh-specific schemes and social work queries. NIMHR Sehore will provide a space to **Vasundhara Welfare Foundation** to do the same at a time and date of their mutual convenience

2.2 NIMHR Sehore shall provide the minimum infrastructural facilities for conducting offline training program /session /Workshops at its center for the mutually planned activities. **Vasundhara Welfare Foundation** will promote these sessions within their parent community through WhatsApp messages or other formal communication routes to ensure maximum participation.

2.3 Vasundhara Welfare Foundation will host workshops for training and awareness (CREs) for the students & professionals of NIMHR Sehore.

3. Support Groups:

3.1 Vasundhara Welfare Foundation will conduct activities promoting, vocational training for PwDs, de-addiction campaign through education, health, environmental protection, culture, and livelihood mission.

4. Partnership acknowledgment

4.1 Vasundhara Welfare Foundation and NIMHR Sehore to share and tag photographs of events/sessions conducted in collaboration on respective social media handles.

4.2 Annual meetings shall be conducted between NIMHR Sehore and **Vasundhara Welfare Foundation** to share updates and plan future events.

5. Period of Validity

5.1 The duration of the Memorandum of Understanding (MoU) will be 3 years, once both parties agree on the detailed scope of work outlined in the proposal, to provide long-term support to families in Madhya Pradesh. It is understood by both parties that this is a working, non-financial MoU.

6. Arbitration

Any dispute arising concerning any aspect of this Agreement shall be settled through mutual consultations and agreements by the parties to the Agreement.

7. Use of Infrastructure

NIMHR Sehore agrees to provide access to its infrastructure and space (classrooms, seminar halls, clinical services etc.) as per mutual agreement for the joint activities, training programs, workshops, and support group meetings organized in collaboration with Vasundhara Welfare Foundation.

8. Nature of MoU

This is a non-financial MoU. No party shall be financially liable to the other under this MoU. The collaboration shall focus on knowledge sharing, joint programs, and capacity building activities without monetary exchange.

9. Services of Experts

Vasundhara Welfare Foundation may engage subject matter experts and professionals for technical sessions, support groups, and workshops conducted in association with NIMHR. NIMHR may also facilitate its internal experts or invite external specialists when required for joint programs, with prior consultation.

10. Technical Guidance and Subject Expertise

Both Parties agree to provide mutual guidance and share subject matter expertise for developing content, training modules, and program frameworks focused on disability inclusion and family support services.

11. Field Visits for Students

Vasundhara Welfare Foundation agrees to facilitate structured field visits for students of NIMHR at its operational centres and project sites. These visits will aim to provide practical exposure, interaction with beneficiaries, and orientation to community-based rehabilitation and inclusive practices without any financial implication.

Phase 2 (Extension and Outreach)

An exchange of information between NIMHR and Vasundhara professionals including orientation workshops.

NIMHR and Vasundhara permitted to use the outcome of the collaboration for/internal use. The following points are also covered in the MOU:

I. Costs & Expenses

Each Party will be responsible for its own costs and expenses individually incurred in connection with this MOU, including, without limitation, the performance of any and all duties or obligations set forth herein.

II. Confidentiality

The Parties agree that any data shared by both parties in relation to this Memorandum of Understanding (Mot) will be held confidential and any breach will result in termination of MoU



III. Organizational identity

The Parties agree to permit usage of their logos on marketing collaterals and related medium for all activities related to the MoU.

IV. MoU Intent

This document is not intended to create legal or binding obligations on either party. It serves only as a record of the parties and current intentions. Before any of the activities set out in this MoU are implemented, to ensure the activities can be recompleted in conformity with the law and so as to enable the principles set out in this MoU to be implemented, the parties shall enter into formal and binding separate agreement or agreements with each other which will detail the specify form and content of the activities and cover the responsibilities and rights of each Party. Such agreements will be negotiated in good faith.

V. Public Announcement

The Parties agree that, without prior review and written approval of other Party, neither Party shall issue press release or otherwise make a public announcement concerning the subject matter of this MoU or make any statements on behalf of or concerning the other Party to press, media, brokers, batiks, and/or any other person. Any public announcement so made, shall be as peer activities outlined in this MoU.

VI. Time Period

This MoU commences from the date of last signing and shall be in force for a period of 3 years. The MoU may be terminated at any time by mutual consent/or by 1 months' notice by either party.

VII. Amendments

It may be amended, modified, extended, of renewed only on the written consent of both Parties. The Institutions agree to review this MoU 1 month prior to the end of the term. No alterations, additional, or modifications hereto shall be valid and bending unless the same reduced to writing and signed by all the Parties.

VIII. Non-Exclusive Discussions

The Parties acknowledge and agree that the Areas of Collaboration under this MoU are being undertaken on a non-exclusive basis and either Party shall be free to enter into or consummate transactions similar to the Areas of Collaboration with other parties in India or elsewhere. The specific terms of this MoU do not preclude the development of future collaborative ventures or projects not mentioned in this document.

IX. Conflict of Interest

Neither of the parties believes that the Collaboration contemplated by this MoU raises any actual or potential conflicts of/interest. The parties agree that this MoU and the negotiation of the same (and any other agreements exerted into in connection herewith) are independent of any past, present, or potential future arrangements, and are not connected to an existing business relationship between either of the parties

X. Working Relationship



The Parties agree and acknowledge to work as an independent agencies/contractor and nothing under this Agreement shall constitute any relationship including but not limited to employer-employee, joint venture or any other relationship. This Agreement doesn't create any Partnership between the Parties.

XI. Assignment







Neither of the Parties shall assign any of their duties under this MoU to any other person or institution without prior approval of the other party.

XII. Liability

One Party be and is hereby indemnified from the liabilities that arise due to the actions of other impacted Employees, their impacted authorized personnel, their impacted representatives etc.

As and when required, both organizations will share their infrastructure, including accommodation and other conference hall facilities, on mutually agreed terms.
